ORDERS OF THE DAY

GOVERNMENT MOTIONS

1. Hon. Mr. Fentie (Motion #69)

THAT this House urges the Government of Yukon to work collaboratively with the Government of Canada, the Government of the Northwest Territories, the Porcupine Caribou Management Board, all affected First Nations in Yukon and the Northwest Territories, and stakeholders, to develop a Porcupine Caribou Herd Harvest Management Strategy that ensures to the greatest extent possible, the conservation and protection of the Porcupine Caribou Herd.

2. Hon. Mr. Fentie (Motion #167)

THAT this House urges the Government of Yukon, the Government of Canada and Yukon First Nation governments to develop a timely, inclusive process through the re-instated Intergovernmental Forum to implement the recommendations of the Nine Year Review of the Yukon Final Land Claims Agreements in order to ensure the spirit and intent of the land claims agreements are fulfilled.

3. Hon. Mr. Kenyon (Motion #239)

THAT this House urges the Government of Yukon to continue to work with the Government of Canada, First Nations, Yukon College, members of the business community and non-governmental organizations to:

- (1) enhance and develop labour market initiatives targeting First Nations, older workers, youth, persons with disabilities and immigrants through measures such as apprenticeship programs, the Youth Employment Program, the Yukon Nominee Program, the Temporary Foreign Worker Program and other programs,
- (2) develop a national recruiting campaign; and
- (3) assist in the development of retention incentives for employers.

4. Hon. Ms. Horne (Motion #713)

THAT this House urges the Government of Canada and its NATO allies to insist in the strongest possible terms that the Government of Afghanistan fully honour its human rights treaty obligations under international laws and demonstrate its commitment both in law and in practice to respect, protect and enforce the equality rights of the women of Afghanistan or face international sanctions.

5. Hon. Mr. Hart (Motion #723)

THAT this House urges the Government of Yukon to support the findings of the Motion #542 Consultation Report done by the Yukon Workers' Compensation Health and Safety Board and the Employment Standards Board, responding to Motion #542 adopted during the 2008 Fall Sitting of the Legislative Assembly, by requesting that the Yukon Workers' Compensation Health and Safety Board and the Employment Standards Board:

- (1) work together within their existing frameworks of authority to appropriately address areas of general consensus;
- (2) work together to ensure adequate training, orientation and supervision of young workers; and
- (3) conduct a review within 5 years to assess the effectiveness of any regulations resulting from this consultation and consider whether there is a need for a general minimum working age in Yukon.

6. Hon. Ms. Horne (Motion #832)

THAT this House urges the Government of Yukon to explore the concept of a multidisciplinary approach to dealing with the complex needs of chronic substance abusers.

7. Hon. Ms. Horne (Motion #935)

THAT this House urges the Government of Canada to meet its obligations under the Yukon First Nation Self-Government Agreements by providing sufficient financial resources to implement these agreements through the Assumption of Responsibilities Agreement (ARA) process; and to demonstrate this commitment by negotiating an appropriate ARA on the administration of justice with the Teslin Tlingit Council.

8. Hon. Ms. Taylor (Motion #941)

THAT this House urges the Government of Canada to work with Canada's tourism industry, provinces and territories and other stakeholders in the development of China Approved Destination Status policies and processes that will enable Canada's tourism sector to capitalize on this opportunity.

9. Hon. Ms. Horne (Motion #1007)

THAT this House urges the Government of Canada to reinstate its funding for the Aboriginal Healing Foundation to ensure that the Kwanlin Dun First Nation, the Liard Aboriginal Women's Society, the Northern Tutchone Tribal Council, and the Committee on Abuse in Residential Schools Society (CAIRS), which have provided services to residential school survivors, can continue their programs.

10. Hon. Mr. Fentie (Motion #1017)

THAT this House urges the Government of Canada to recognize Yukon Self-Governing First Nations as a senior level of government, by working with the first seven Yukon First Nations

who settled their land claims to develop new Financial Transfer Agreements that include an economic development incentive allowing Yukon First Nations to retain an appropriate percentage of their own source revenues.

11. Hon. Ms. Horne (Motion #1033)

THAT this House urges the Government of Yukon, in conjunction with “M” Division of the Royal Canadian Mounted Police, to conduct a review of policing in Yukon that:

- (1) reflects the RCMP’s commitment to become more constructively self-critical, more transparent and accountable to its own employees, to the government and to the Canadian public,
- (2) seeks to assist “M” Division in implementing in Yukon the RCMP’s national commitment to transformation,
- (3) is co-chaired by the RCMP’s Commanding Officer of “M” Division and the Deputy Minister of Yukon’s Department of Justice, who will undertake the review in consultation with an Advisory Committee comprised of one representative from each of the following:
 - (a) Yukon First Nations,
 - (b) Yukon Municipalities,
 - (c) Yukon Women’s groups,
 - (d) the RCMP,
 - (e) the Women’s Directorate,
 - (f) the Department of Community Services,
 - (g) the Department of Health and Social Services, and
 - (h) the Department of Justice;
- (4) will have the following priorities:
 - (a) considering measures and making recommendations to better ensure that Yukon’s police force is responsive and accountable to the needs of Yukon citizens,
 - (b) reviewing how public complaints relating to the RCMP in Yukon are currently dealt with and making recommendations on any required improvements,
 - (c) determining the skills that Yukon officers require in order to provide policing services in Yukon communities and making recommendations to enhance training, including the potential for Yukon based training,
 - (d) reviewing the services provided by the RCMP to citizens who are in vulnerable positions, including victims of domestic violence and sexual assault, as well as individuals who have been arrested and detained in custody,
 - (e) identifying and building upon successes and best practices in the delivery of policing services to Yukon, and
 - (f) reviewing and making recommendations on how best to implement in Yukon the existing RCMP policy on External Investigations and Reviews; and
- (5) has the co-chairs, through community and targeted consultations produce a written report to be submitted to Yukon’s Minister of Justice no later than September 15, 2010.

NOTICE PAPERMOTIONS OTHER THAN GOVERNMENT MOTIONS

1. Mr. Nordick (Motion #1035)

THAT this House urges the Government of Yukon through its policies, programs, multi-year expenditure plans and diversification and marketing initiatives, to continue to promote the growth and development of Yukon's private sector economy in order to increase the private sector's current contribution in relation to the \$600 million capital expenditures planned for the 2010-2011 fiscal year.

2. Mr. Nordick (Motion #1036)

THAT this House urges Yukon's Member of Parliament, Larry Bagnell, to support the wishes of a vast majority of his constituents and vote for private member's Bill C-391, An Act to Amend the Criminal Code and Firearms Act (repeal of long-gun registry) presented by the Member of Parliament for Portage-Lisgar, Candice Hoepfner.

3. Mr. Elias (Motion #1037)

THAT this House urges the Government of Yukon to not further proceed with Bill #82, Civil Forfeiture Act, until public consultation has taken place on the proposed legislation.

4. Mr. Fairclough (Motion #1038)

THAT this House urges the Minister of Environment to refrain from speaking on behalf of self-governing First Nations and to respect the ability and authority of First Nations governments to make their own decisions regarding what they see as priorities.

5. Mr. Cardiff (Motion #1039)

THAT this House urges the Yukon Government to introduce amendments to the *Quartz Mining Act* during the 2010 Fall Sitting of the Legislative Assembly that would prohibit mineral staking within municipal boundaries in order to:

- (1) reduce the potential for conflicts,
- (2) ensure better environmental protection and land-use planning objectives; and
- (3) modernize the Act as suggested by the Minister of Community Services at the 2010 annual meeting of the Association of Yukon Communities.

6. Mr. Cardiff (Motion #1040)

THAT this House urges the Minister responsible for consumer protection to raise with his federal counterparts, at the next opportunity, the inadequacy of the recently-enacted voluntary Code of Conduct for credit card companies and urge the Federal Government to bring forward real proposals that would help average Canadians by lowering rates for credit card and debit card transactions and providing some debt relief.
